Professor Bora is the former Chief Financial Officer and Director of Finance and Management at the New Jersey Meadowlands Commission where he managed the financial operations of the agency and served

as the administrator of the Meadowlands Intermunicipal Tax Sharing Formula. He has helped direct the Masters Degree Program in Governmental Accounting as its Associate Director for over 10 years. He was instrumental in developing the online component of the program making it the first complete online graduate program at the Rutgers Business School.

Professor Bora has taught courses in governmental accounting and auditing and design and development of information systems. He brings into the classroom public financial management expertise covering a broad spectrum of experience with real-world applications and strong relationships with leaders in the field thus offering students career advice and planning.

Curriculum

Our program requires the completion of 10 courses (30 credit hours) -- seven required courses (21 total credits) and three elective courses (9 total credits). Our curriculum has been developed with the input of leaders in government financial management. Many of the courses have been designed and are taught by these experts, and case studies and real-world examples are essential components of the program. In addition, students participate in virtual team projects and are often presented with the opportunity to assist with standard-setting research.

Certificate Program

Our online Graduate Certificate in Government Financial Management is a great alternative if you aren't ready to pursue a master's program. These courses will also prepare you to sit for the Certified Government Financial Manager (CGFM) exam and can be applied toward a future 10-course master's degree program.

Admissions

Program candidates should have a bachelor's degree in accounting or related work experience in knowledge areas typically covered in an undergraduate accounting degree. Admission to the program is competitive, and candidates must meet the graduate admissions requirements of Rutgers Business School.
